Why are we asking for extra information? We ask for extra information to help ensure that this is a legitimate request and the software will be used for legitimate purposes. All information provided to us will be kept strictly confidential and is only used to process your request. We will never sell, share or otherwise distribute the information. The only exception is if required to do so by legal action.

You agree that the software will be used for legitimate purposes only, and will not be used by any person or entity other than the registered company. Should the mail server OHN change, you will be required to submit a letter on company letterhead explaining the change to request a new license code. You agree to pay for any and all costs associated with any legal or collection action that may arise out of your purchase of a license to the software. Any and all documentation and software remains the property of eServices For You, and can not be copied (except for backup purpose), shared, distributed, reverse engineered or otherwise used. You are purchasing a license to use the software on one server per license only for use within Declude JunkMail. Any unauthorized or un-permitted use may be prosecuted, and if prosecuted you will be responsible for all costs of such action.
